OAC rule 4765-1-03 includes titles, dates of publication, and information to help readers access materials incorporated by reference in the emergency medical services (EMS) chapters of OAC 4765. Commas have been deleted from some of the publication

dates and, in seven items, titles, dates of publication, or Web addresses have been amended.

OAC rule 4765-1-03 includes titles, dates of publication, and information to help readers access materials incorporated by reference in the emergency medical services (EMS) chapters of OAC 4765. Thirty-seven items are included in OAC Chapter 4765-1-03.

Twenty-nine of the materials cited in OAC Rule 4765-1-03 are published at the EMS website or the EMS website provides instructions to obtain the materials. Web addresses are included in rule 4765-1-03 to access these materials. Of these 29 items, 7 are archived curricula documents obtained by contacting the Division of EMS; PDFs of these documents are filed with this rule.
