This rule is being proposed in accordance with HB 401 (126th G.A.). This bill requires the Executive Director of the Division of EMS, with advice and counsel of the Firefighter and Fire Safety Inspector Committee, to adopt rules regarding, in general, training and education standards and certification and renewal requirements for firefighters, fire safety inspectors, fire instructors, and fire charters, as well as disciplinary guidelines and procedures for such certificate holders.

This rule sets forth the requirements for the issuance of a charter to an applicant that meet or exceeds the requirements and establishes the rules for maintaining documentations of fire service training conducted by an aproved charter.
