**Revocation of a charter.**

- (A) The executive director, with the advice and counsel of the ~~subcommittee~~ **committee**, may suspend or revoke a charter issued under section 4765.55 of the Revised Code and this chapter for any of the following:
- (1) Failure to meet the minimum standards for chartering set forth in this chapter;
  - (2) Violation of any provision of Chapter 4765. of the Revised Code or this chapter;
  - (3) Furnishing false, misleading, or incomplete information to the executive director;
  - (4) Violation of any commitment made in an application for a charter;
  - (5) Presentation to prospective students of misleading, false, or fraudulent information relating to any programs, employment opportunities, or opportunities for enrollment in accredited institutions of higher education after entering or completing courses offered by the program;
  - (6) Failure to maintain premises and equipment in a safe condition;
  - (7) Failure to maintain financial resources sufficient for the continued operation of the program in the manner set forth in the application for charter;
  - (8) Discrimination in the acceptance of students on the basis of race, color, religion, sex, or national origin.
- (B) Notice shall be provided when a suspension or revocation of a charter issued under section 4765.55 of the Revised Code and this chapter, is considered.
- (1) The notice shall set forth the nature of the action under consideration and the specific reasons for the proposed action.
  - (2) The notice shall be provided to the program director of the chartered training program in question.
  - (3) The notice shall state that the chartered program may request a hearing in accordance with Chapter 119. of the Revised Code and that such hearing must be requested within thirty days of the mailing date of the notice of proposed action.

- (C) If a hearing is requested on a proposed suspension or revocation, the hearing shall be conducted in accordance with Chapter 119. of the Revised Code by the ~~subcommittee~~ committee, or, if the ~~subcommittee~~ committee chooses, by a hearing officer.
- (D) The executive director, with the advice and counsel of the ~~subcommittee~~ committee, and in accordance with Chapter 119. of the Revised Code and this chapter, may order a term of suspension or revocation of the charter.
- (E) A program whose charter has been suspended may not conduct, offer, or promote its program during the period for which the charter is suspended.
- (F) A program whose charter has been revoked may not apply for reinstatement prior to the date upon which the charter would otherwise have expired.
