This rule is being filed according to a R.C. 119.032 review. This rule is also proposed to replace existing rule 4765-11-09 due to fifty percent guideline. It is estimated that changes to the new rule strike approximately fifty percent of the text in the existing rule while adding a comparable amount of new text.

The rule sets forth the volunteer firefighter course hours and content. Changes to this new rule remove NIMS courses and NFPA standards from the curriculum requirements. The NIMS course references have been moved to rules 4765-20-02 and 4765-20-03 of the Administrative Code. The NFPA standards were removed as they refer to live burn evolutions which are not part of a volunteer firefighter course. Additionally, language was added to this rule to identify that the dates and availability of materials incorporated by reference are located in paragraph (CC) of rule 4765-11-01(N).
