This bill requires the Executive Director of the Division of EMS, with advice and counsel of the Firefighter and Fire Safety Inspector Committee, to adopt rules regarding, in general, training and education standards and certification and renewal requirements for firefighters, fire safety inspectors, fire instructors, and fire charters, as well as disciplinary guidelines and procedures for such certificate holders.

New language requires students taking a Firefighter II course to submit proof of successful completion of NIMS training. This requirement is already listed in former rule 4765-11-03 and is being moved to each respective curriculum rule. As such, there is no additional cost of compliance. Schools have the ability to enter into written affiliation agreements to provide equipment and apparatus necessary to complete the training requirement. Students enrolling in the Firefighter II course

must still pay for the cost of the course, which is approximately \$1,200.00; however cost will vary by location. There is no cost to county or municipal governments for these courses unless they choose to pay the costs of the individual's Firefighter II course. Partial reimbursement is available through the State Fire Marshal's office.
