Fire instructor and assistant fire instructor course.**RULE SUMMARY**

6. State the reason(s) for proposing (i.e., why are you filing,) this rule:

This rule is being filed according to a R.C. 119.032 review. This rule is also proposed to replace existing rule 4765-11-15 due to LSC's fifty percent guideline. It is estimated that changes to the new rule strike approximately fifty percent of the text in the existing rule while adding a comparable amount of new text.

The rule sets forth the course hours and content requirements for the fire instructor and assistant fire instructor course. Changes to this rule decrease the minimum number of hours required in instruction of adult students and basic teaching techniques, from seventy (70) hours to sixty (60) hours. This change is being made to maintain consistency in the course requirements for fire and EMS instructors since the instructor curriculum is universal for both EMS and fire. Additionally, language was added to this rule to identify that the dates and availability of materials incorporated by reference are located in in paragraph (CC) of rule 4765-11-01(N) (See filing package 114977).

This rule incorporates the "Ohio Fire and EMS Instructor Curriculum," (November, 2013), the "Fire Service Training Module," (October, 2013), and "Live Fire Training Awareness Course," (October, 2013) by reference. To comply with sections 121.71 to 121.74 of the Revised Code, this rule refers readers to paragraph (CC) of rule 4765-11-01(N) (See filing package 114977), which addresses the version/date of the material, as well as its availability via http://ems.ohio.gov/ems_fire_srvcs.stm.

A.) Does this rule require a license, permit, or any other prior authorization to engage in or operate a line of business? **No**

This rule, in and of itself, does not require prior authorization to engage in business. However, it is part of a filing package that does, as some provisions in Chapter 4765-11 require fire service training programs to receive approval from the EMS executive director for a program charter prior to offering courses at the following classification levels: volunteer firefighter, firefighter I, firefighter II, fire safety inspector, fire instructor or fire safety instructor.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

This rule, in and of itself, does not impose a penalty or sanction. However, it is part of a filing package that does, as some provisions in Chapter 4765-11 establish that an administrative sanction up to and including revocation of a fire service training program charter or classification may be imposed for violations of Chapter 4765-11 of the Administrative Code pursuant to rule 4765-23-02 of the Administrative Code.
