This rule is being filed in accordance with Section 119.032 of the Revised Code. New language is being added to increase the number of hours of the First Responder course from 40 to 48 hours.

This rule sets forth the curriculum for a First Responder training program. New

language increases the minimum number of course hours from 40 hours to 48 hours. In addition, new language allows a training program to provide credit for 40 hours if the student completes a health-care professional course or rescue course through one of three specified organizations.
