This rule is proposed for amendment, in part, to require an emergency medical responder training program that begins on or after September 1, 2012 to meet the revised curriculum standards established and adopted by the EMS board in rule 4765-12-05 of the Administrative Code. Additionally, the rule is being amended to implement statutory changes set forth by Sub. H.B. 128, 129th General Assembly which deems a reference to a first responder as a reference to an emergency medical responder or EMR.

The rule sets forth the current curriculum standards to be met by an emergency medical training program that begins prior to September 1, 2012. The rule is amended to direct an emergency medical responder training program which begins on or after September 1, 2012, to follow the curriculum standards established and adopted by the EMS board in accordance with rule 4765-12-05 of the Administrative Code. Also, the reference to "first responder" was changed to "emergency medical responder."
