This rule is being adopted for the purpose of reorganizing Chapter 4765-12 of the Administrative Code. The content of this rule was previously contained in former 4765-12-03. As such, there is no additional cost of compliance. First responders must still pay for the cost of the first responder course, which is approximately \$300; however, the amount will vary by location. First responders required to take the refresher course must pay approximately \$90, although the exact amount will vary by location. There is no cost to county or municipal governments for these courses unless they choose to pay the costs for the individual first responder; these costs may then be offset by grant money from the Division of EMS.
