As such, there is no additional cost of compliance. First responders must still pay the cost of obtaining their continuing education requirements. The cost for meeting the continuing education requirements is appoximately \$100, and will vary by location. There is no cost to county or municipal governments unless they choose to pay the cost for the individual first responder; this cost may then be offset by grant money from the Division of EMS.
