This rule is being proposed by the EMS board in part, to establish the curriculum standards for an emergency medical responder training program and an emergency medical responder refresher program that begins on or after September 1, 2012. Additionally, this rule implements statutory changes set forth by Sub. H.B. 128, 129th General Assembly to amend the definition of first responder to also be known as emergency medical responder or EMR.

The rule sets forth the curriculum standards to be followed by an emergency medical responder training program and emergency medical responder refresher program that begins on or after September 1, 2012. The emergency medical responder curriculum is based on the national EMS education standards as approved by the United States National Highway Traffic Safety Administration and in accordance with the curriculum standards and scope of practice as established and adopted by the EMS board.
