This rule is being filed in accordance with Section 4765.40(C) of the Revised Code which requires the State Board of Emergency Medical, Fire and Transportation Services to review these rules at least every three years and to modify them as necessary to minimize overtriage and undertriage.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule sets forth specific criteria for EMS personnel to use in evaluating whether an injured person qualifies as an adult, geriatric or pediatric trauma victim. Criteria to consider includes anatomic and physiologic conditions in addition to mechanism of injury and special considerations as taught in EMS curricula.

4765-14-02 (A)(1)(f) and 4765-14-02 (C)(1)(g) broadens the triage indicator for adult and geriatric victims, respectively, from the need for a specific procedure (endotracheal intubation) to the indication of need for a broad category of procedures (need for ventilatory support) to align with the current science;

4765-14-02 (A)(2)(g), 4765-14-02 (B)(2)(g) and 4765-14-02 (C)(2)(h) adds a triage indicator (open skull fracture) in each age group that was unintentionally omitted previously;

4765-14-02 (A)(3)(a), 4765-14-02 (A)(1)(f) and 4765-14-02 (A)(1)(f) adds a triage indicator in each age group that is a result of advancements in vehicle telematics;

4765-14-02 (B)(1)(f) adds a triage indicator (respiratory rate <20 in infants <1 year old) that was unintentionally omitted previously;

4765-14-02 (D) revises the titles of EMS personnel to reflect the same changes in Revised Code 4765.01.
