This rule is being adopted as part of a comprehensive review and reorganization of several EMS rules. This reorganization will allow readers greater ease in accessing and understanding the rules in Chapters 4765-1 to 4765-19 of the Ohio Administrative Code.

This rule outlines the required curriculum for EMT-basics for initial certification and refresher training. This rule is being created from language removed from 4765-6-03 to make the rules more convenient for the user.

This rule is being adopted as part of a comprehensive review and reorganization of several EMS rules. This rule was previously numbered 4765-6-03, which is being rescinded and renumbered as 4765-15-01. As such, there is no additional cost of compliance. EMT-basics must still pay for the cost of the EMT-basic course, which is approximately five hundred dollars (\$500); however, the amount will vary by location. EMT-basics required to take the refresher course must pay approximately two hundred dollars (\$200), although the amount will vary by location. There is no cost to county or municipal governments for these courses unless they choose to pay the costs for the individual EMT-basic; these costs may then be offset by grant money from the Division of EMS.
