This rule is being amended to clarify the continuing education requirements to successfully renew an EMT-Basic certificate to practice.

This rule stipulates the continuing education hours required for renewal of an EMT-basic certificate to practice. The EMT-Basic may take forty hours of

continuing education with certain stipulated topics, take an approved refresher course, maintain National Registry of Emergency Medical Technicians certification or take the examination in lieu of continuing education. Language has been added to clarify that all renewal requirements must be completed by the expiration date of the current certificate or the expiration date of a granted extension. The requirement of eight hours of trauma issues to include the completion of trauma triage and transportation of protocols was amended.
