The rule sets forth the conditions under which the board will renew an emergency medical technician certificate to practice. The amended language clarifies that an individual who receives a board approved extension of time to complete continuing education requirements must submit the renewal application to the division no later than the expiration date of the granted extension. Also, the reference to "EMT-basic" was changed to "emergency medical technician."
