This rule refers to a one-time renewal requirement for First Responders and EMTs, listed in 4765-8-04, to complete the Hazmat and WMD course and the Health Crisis Planning course. Currently, the Hazmat and WMD course is being offered through the Ohio Fire Academy at no cost. The Health Crisis course is not currently being offered at an accredited or approved site. As such, it is difficult to determine with certainty how much the course will cost. The course is approximately 1.5 hours. Most schools charge an average of \$10.00 per hour for a course. Therefore, it is not anticipated that applicants will incur more than \$20.00 for this course. Any potential costs may be offset if the EMS organization with which the EMT is affiliated applies for grant funding to cover training costs.
