The approximate cost to an individual to complete an EMT-intermediate course is five hundred dollars (\$500), which is approximately two hundred dollars more than under the previous rule (4765-6-04); however, this cost will vary by location. EMT-intermediates required to take the refresher course must pay approximately three hundred dollars (\$300), although the amount will vary by location. There is no cost to county or municipal governments unless they choose to pay the costs for the individual EMT-intermediate; these costs may then be offset by grant money from the Division of EMS.
