This rule is being amended by the EMS board in part, to clarify the continuing education requirements to successfully renew an advanced EMT or EMT-intermediate certificate to practice. Additionally, the rule is being amended to implement statutory changes set forth by Sub. H.B. 128, 129th General Assembly which deems a reference to an EMT-intermediate as a reference to an advanced emergency medical technician or AEMT.

The rule sets forth the conditions under which the board will renew an advanced emergency medical technician certificate to practice. The amended language clarifies that an individual who receives a board approved extension of time to complete continuing education requirements must submit the renewal application to the division no later than the expiration date of the granted extension. Also, the reference to "EMT-I" was changed to "advanced emergency medical technician."
