Rule 4765-16-04 sets forth the emergency medical services that may be performed by an advanced emergency medical technician (AEMT) and the conditions under which the services may be performed. The rule states that a medical director for an Page 2 Rule Number: **4765-16-04**

emergency medical organization may limit the scope of practice for AEMTs within the organization. The rule requires AEMTs performing emergency medical services within the scope of practice to have received training as part of their initial certification course or through subsequent training approved by the EMFTS board, or in certain emergency medical services, after having received training approved by the local medical director. The rule is amended with the addition of Ketamine in paragraph (B)(1) to the list of medications that can be administered.
