New emergency medical procedures have been added to the rule, including, in part,

replacement of a tracheostomy tube through a stoma and 12-lead electrocardiogram application. New language also references new rule 4765-6-04 (the research rule) as being additional services that an EMT-intermediate may perform. Lastly, paragraph (D) was included to clarify that certain services may not have been originally included in initial training for EMT-intermediates who were certified several years ago. In those instances, the EMT-intermediate's medical director can approve such training, provided it is within the EMT-intermediate's scope.
