This rule is being filed according to a R.C. 119.032 review. This rule is also proposed to replace existing rule 4765-20-02 due to fifty percent guideline. It is estimated that changes to the new rule strike approximately fifty percent of the text in the existing rule while adding a comparable amount of new text.

of the proposed rule; If the rule type is RESCISSION, NEW or NO CHANGE, then summarize the content of the rule:

This rule establishes the requirements that an applicant shall meet in order to obtain a certificate of firefighter training. Changes to this new rule include the requirement to complete the National Incident Management System (NIMS) courses mandated by the United States' Department of Homeland Security. Also, an applicant for firefighter I or firefighter II will have to complete a course on hazardous materials awareness and operations in order to be eligible for certification. Credit can be granted for the hazardous material course if taken in the past twenty-four months. Additionally, language was added to this rule to identify that the dates and availability of materials incorporated by reference are located in rule 4765-11-01(N) (See Filing Package 114977) of the OAC.

This rule incorporates the "Firefighter or Fire Safety Inspector Initial Application," the Federal Emergency Management Agency's (FEMA) National Incident Management System (NIMS) courses IS-700 and IS-100, and National Fire Protection Association (NFPA) standards. To comply with sections 121.71 to 121.74 of the Revised Code, this rule refers readers to paragraph (CC) of rule 4765-11-01(N) (See filing package 114977), which addresses the version/date of the materials, as well as where each may be accessed.

9. If the rule incorporates a text or other material by reference, and it was **infeasible** for the agency to file the text or other material electronically, provide an explanation of why filing the text or other material electronically was infeasible:

In compliance with R.C. 121.73, "Firefighter or Fire Safety Inspector Initial Application" is being filed as part of new rule 4765-11-01 (See filing package 114977), which addresses the version/date of incorporated materials, as well as where they may be accessed.

However, the NIMS courses and NFPA standards are not, as these materials are copyrighted and available only via the Federal Emergency Management Agency's website at www.fema.gov and the National Fire Protection Association (NFPA) website at www.nfpa.org. To comply with sections 121.71 to 121.74 of the Revised Code, these materials are fully addressed in rule 4765-11-01(N) (See filing package

114977), which provides full citation, date/version of the materials, and availability.

does not require prior authorization, however, it is part of a filing package that does, as some provisions in Chapter 4765-20 require firefighters and fire safety inspectors to apply for the appropriate certificate issued by the EMS executive director prior to engaging in fire services.
