This rule outlines the process of applying for a certificate of fire training. Other than paragraph (D), there will be no increased cost of compliance for firefighters as this is now an online application process. Paragraph (D) requires a firefighter with a criminal conviction to provide written notification to the Division of EMS, including a certified copy of the judgment entry and police report and a background check from BCI&I. However, these requirements only apply to those firefighters with a criminal conviction (a small percentage of the total number of firefighters). Such firefighters will have to pay approximately \$15 to obtain a BCI&I criminal background check and will incur minimal copying charges to send a certified copy of the police report and judgment entry to the Division.
