This rule is being filed pursuant to a completed R.C. 119.032 five-year rule review. This rule is being proposed for rescission due to LSC's fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text while adding a comparable amount of new text. This rule is simultaneously being proposed as a new rule under the same rule number.

This rule sets forth the application process for firefighter, fire safety inspector, and instructor.

While these forms are commonly known and made generally available to affected persons, this rule did not originally address these materials in compliance with sections 121.71 to 121.74 of the Revised Code. This rule is simultaneously proposed for rescission and adoption under this same rule number, in part, to address these materials. The new rule, under this same rule number, will refer readers to rule 4765-11-01(N) (See filing package 114977) where all materials incorporated by reference in Chapter 4765-11 and Chapters 4765-20 to 4765-23 are addressed.

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. This rule, in and of itself, does not require prior authorization to engage in business. However, it is part of a filing package that does, as some provisions in Chapter 4765-20 require firefighters and fire safety inspectors to apply for the appropriate certificate issued by the EMS executive director prior to engaging in fire services.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule provided that failure to comply with the terms set forth in this rule may result in an application for firefighter/instructor or fire safety inspector/instructor to be deemed incomplete.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule required applicants who had been convicted of specific offenses to submit a certified copy of the police report, judgment entry and BCI&I background check within sixty days of the final sentencing. The individual may have incurred fees up to \$60.00 which includes \$35.00 for the background check, \$15.00 for the police report and \$15.00 for the judgment entry as a condition of compliance.
