This rule, in and of itself, does not require prior authorization to engage in business. However, it is part of a filing package that does, as some provisions in Chapter 4765-20 require firefighters and fire safety inspectors to apply for the appropriate certificate issued by the EMS executive director prior to engaging in fire services.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **No**

This rule, in and of itself, does not impose a penalty or sanction. However, it is part of a filing package that does, as administrative sanction up to and including revocation of a firefighter or fire safety inspector certificate may be imposed for certain violations of Chapter 4765-20 of the Administrative Code pursuant to rule 4765-23-02 of the Administrative Code.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

This rule requires a fire services certificate holder to provide written notice to the executive director no later than thirty days following any changes in the certificate holder's personal contact information along with verification of such change if to the certificate holder's legal name.
