Language was added to clarify the type of examination needed for initial or reinstatement certification. The rule has also been amended to include number of permissible attempts and passing scores.

This rule, in and of itself, does not impose a penalty or sanction. However, it is part of a filing package that does, as administrative sanction up to and including revocation of a firefighter or fire safety inspector certificate may be imposed for certain violations of Chapter 4765-20 of the Administrative Code pursuant to rule 4765-23-02 of the Administrative Code.
