The rule requires the Division to notify each person of the expiration date of the individual's firefighter or fire safety inspector certificate no later than sixty days prior to the expiration date. The rule states that renewals become effective on the expiration date of the current certificate. The rule refers readers to an incorporated by reference rule.

O.A.C. Rule 4765-20-07 is amended to remove the requirement to possess a current and valid firefighter certificate to renew a Fire Safety Inspector or Hazard Recognition Officer certificate, and to remove the reference to application fees in the rule.
