Renewal of a certificate of fire training.**RULE SUMMARY**

This rule is being filed pursuant to a completed R.C. 119.032 five-year rule review. This rule is being proposed for rescission due to LSC's fifty percent guideline. It is estimated that changes to the rule strike approximately half of the existing text while adding a comparable amount of new text. This rule is simultaneously being proposed as a new rule under the same rule number.

This rule sets forth the renewal requirements for a firefighter and fire safety inspector certificate.

The material incorporated by reference in this rule includes an agency application. While this form is commonly known and has been made generally available to affected persons, this rule did not originally address the material in compliance with sections 121.71 to 121.74 of the Revised Code. This rule is simultaneously proposed for rescission and adoption under this same rule number, in part, to address these materials. The new rule, under this same rule number, will refer readers to rule 4765-11-01(N) (See filing package 114977) where all materials incorporated by reference in Chapter 4765-11 and Chapters 4765-20 to 4765-23 are addressed.

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule required fire training certificate holders to renew their certificates prior to continuing to engage in providing fire services.

B.) Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? **Yes**

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule provided that failure to comply with the terms set forth in this rule may result in a renewal application for a fire training certificate to be denied.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule required applicants to maintain records that documented his or her completion of the continuing education set forth in rules 4765-20-13 and 4765-20-16 of the OAC. This impact was estimated to be minimal.
