This rule is simultaneously being proposed as a new rule under the same rule number.

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule required applicants to maintain records that documented his or her completion of the continuing education set forth in rules 4765-20-13 and 4765-20-16 of the OAC.
