These rules are being filed as part of a comprehensive five-year rule review and reorganization of the fire training rules in agency 4765 of the OAC, at the request of stakeholders. OAC chapters governing fire charters, fire service and fire instructor training, professional standards, and discipline are proposed to be made consecutive chapters in OAC 4765, and a chapter including definitions and items incorporated by reference as two separate rules has been added. At the request of stakeholders, proposed revisions add language creating a live fire instructor (LFI) certification and a hazard recognition officer (HRO) certification.

OAC Rule 4765-20-08 sets forth the requirements to reinstate a firefighter or fire safety inspector certificate that has expired or has been voluntarily surrendered including timelines, examination requirements, continuing education requirements, and application fees for reinstatement. This rule provides options for examination and meeting continuing education requirements for other reinstatement applicants. The rule refers readers to an incorporated by reference rule. OAC Rule 4765-20-08 is amended to include requirements for renewal of a hazard recognition officer certificate, a level that is added as part of this rule review and revision process. The qualifications are listed sequentially for each certificate level, and references are revised to reflect the reorganized rules. The executive director's reinstatement window â six months from the date of expiration of surrender â has been revised to eighteen months. The rule references are corrected based on the revised organization of the rules and chapters.

The estimated cost of compliance for stakeholders to apply for reinstatement of a certificate is \$75. The \$75 reinstatement fee must be paid when a certification has expired, becomes invalid due to voluntary surrender, or has been previously revoked. In addition, the cost of compliance may include costs of classes or testing to obtain the required level of skill and knowledge or continuing education credit. These costs may vary from \$0 to \$2500, depending on the time elapsed since the expiration, surrender, or revocation and the certification level sought. Other cost variables include the rate of pay for instructors, the size of the charters/institutions, and student enrollment. Tuition may be paid by the fire department sponsoring a student. Fire departments may request reimbursement of costs through the State Fire Marshal Fire training grant programs.
