This rule is being rescinded and simultaneously proposed for adoption under this same rule number, and in and of itself, it does not require prior authorization to engage in business. However, it is part of a filing package that does, as some provisions in Chapter 4765-20 require firefighters and fire safety inspectors to apply for, renew, and maintain the appropriate certificate issued by the EMS executive director prior to engaging in fire services.

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule provided that failure to comply with the terms set forth in this rule may result in an application for a certificate in lieu of attending a chartered training program to be denied.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

This rule is being rescinded and simultaneously proposed for adoption under this same rule number. However, this rule provided that an applicant for a certificate in lieu of attending a chartered training program must submits documentation that established when the applicant began serving as a firefighter, including but not limited to certified copies of personnel records, certified copies of historical records, or any other affidavits required by the executive director to verify the applicant's employment dates, as well as documentation that establishes that the applicant has maintained active participation in a fire department for at least five years prior to the date of submitting an application.
