This rule is being proposed in accordance with HB 401 (126th G.A.). This bill requires the Executive Director of the Division of EMS, with advice and counsel of the Firefighter and Fire Safety Inspector Committee, to adopt rules regarding, in general, training and education standards and certification and renewal requirements for firefighters, fire safety inspectors, fire instructors, and fire charters, as well as disciplinary guidelines and procedures for such certificate holders.

This rule establishes the process for individuals outside the state of Ohio to apply for a certificate of fire training.

This rule will not cause any cost of compliance for most applicants as they only have to provide the Division with the required documents to process the equivalency and issue the certification, which can be done by standard mail or fax. A small percentage of certificate holders (i.e., those firefighters who were revoked due to having a criminal conviction) may incur costs associated with submitting a BCI&I criminal background check, as referenced in 4765-20-04 of the Administrative Code. Such firefighters will have to pay approximately \$15 to obtain the background check and will incur minimal copying charges to send a certified copy of the police report and judgment entry to the Division.
