This rule sets forth the procedure by which an equivalency fire instructor certificate will be granted (i.e., an applicant who completed courses of instruction in another state, territory, foreign country, etc). This rule will not cause any cost of compliance for most applicants as they only have to provide the Division with the required documents to process the equivalency and issue the certification, which can be done by standard mail or fax. A small percentage of certificate holders (i.e., individuals with a criminal conviction) may incur costs associated with submitting a BCI&I criminal background check, as referenced in 4765-20-04 of the Administrative Code. Such instructors will have to pay approximately \$15 to obtain the background check and will incur minimal copying charges to send a certified copy of the police report and judgment entry to the Division.
