O.A.C. 4765-5-03 sets forth the general provisions of the grant program funded by

the Division of EMS trauma and emergency medical services fund. R.C. 4765.07 requires the State Board of Emergency Medical, Fire, and Transportation Services (EMFTS) to administer the grant program. Proposed changes to O.A.C. 4765-5-03 include: correcting the name of the source of funds to the "trauma and" emergency medical services fund; updating the discrimination language to be consistent with other recently revised EMS rules by adding "age" and "gender" and changing "sex" to "sexual orientation"; changing "shall" to "may" in paragraph (B) concerning the annual solicitation of grant proposals. In addition, the proposed changes incorporate recommendations to eliminate potential conflicts of interest in the grant administration and approval process, based on consultation with the Ohio Ethics Commission and the DPS legal staff. The changes delegate some duties to the Division of EMS from the State Board of EMFTS.
