This rule is being filed according to a R.C. 106.03 review.

The rule sets forth the restrictions and requirements applied to the grant program

funded by the Division of EMS trauma and emergency medical services fund. R.C. 4765.07 requires the State Board of Emergency Medical, Fire, and Transportation Services (EMFTS) to administer the grant program. Proposed changes to O.A.C. 4765-5-05 include: adding a comment regarding incorporated references; deleting a reference to sixth priority grants, which will no longer be available when the proposed rules become effective, and rewording paragraphs (A) and (E) of the proposed rule for clarity. Administrative information provided in the applications and grant agreements is deleted from the rule. Because the attorney general's office, rather than the board, would determine if funds were inappropriately expended, the reference to the board making that determination has been deleted from the proposed (F). In addition, the proposed changes incorporate recommendations to eliminate potential conflicts of interest in the grant administration and approval process, based on consultation with the Ohio Ethics Commission and the DPS legal staff. The changes delegate some duties to the Division of EMS from the State Board of EMFTS.
