This rule replaces the old rule by changing the order of priorities 2, 3, and 4 and adds two new priorities. Priority 5 gives the EMS Board the flexibility to conduct needed EMS specific research. Priority 6 provides grants to state approved paramedic programs seeking national accreditation.
