Rule O.A.C. 4765-06 is being proposed for rescission, as part of a R.C. 106.03 periodic rule review, because it duplicates information included in R.C. 4765.07

O.A.C. 4765-5-06 repeats the list of six grant priorities and the eligibility

requirements for grant priority (A)(6) as set forth in R.C. 4765.07 Administrative rules for grant program. All references to (A)(6) of R.C. 4765.07 have been deleted from the proposed revisions to O.A.C. Chapter 4765-5, because they concern grants distributed no later than the award year ending June 30, 2017, which exceeds the timeframe of the effective date of the proposed rules. O.A.C. 4765-5-06 also describes the source of funds as the "trauma and emergency medical services fund created by section 4513.263 of the Revised Code." The source of funds was previously included in O.A.C. 4765-5-03 General provisions as "emergency medical services fund." The proposed revision to O.A.C. 4765-5-03 corrects the name of the source of funds to include "trauma and" emergency medical services fund.
