However, it is part of a filing package that does as some provisions in Chapter 4765-7 of the Administrative Code (O.A.C.) require institutions to receive approval from the Emergency Medical, Fire, and Transportation Services Board (Board) for a certificate of accreditation prior to offering emergency medical responder (EMR), emergency medical technician (EMT), advanced emergency medical technician (AEMT) or paramedic training programs. Provisions in section 4765.50 of the Revised Code (R.C.), establish that no person shall operate an EMS training program without a certificate of accreditation issued under R.C. 4765.17.
