This rule imposes prior authorization requirements that must be complied with in order to offer online or distance learning. Requirements include those set forth in rule OAC 4765-7-02; possession of a certificate of accreditation for the preceding three years, at minimum; and completion of at least one traditional classroom EMS training program at or above the level of EMS training program to be offered via an on-line or distance learning system.

B. Does this rule impose a criminal penalty, a civil penalty, or another sanction, or create a cause of action, for failure to comply with its terms? Yes

Approval of online education and/or distance learning to offer EMS training may be denied to an applicant who fails to meet the requirements set forth in OAC 4765-7-12.

C. Does this rule require specific expenditures or the report of information as a condition of compliance? Yes

Approval of online education and/or distance learning requires submission of a written request to offer to offer EMS training via alternative delivery systems. An accredited institution approved to utilize online education and/or distance learning systems is required to provide annually to the division information, statistics, and data specific to the EMS training programs offered through online and/or distance learning as set forth in rule 4765-7-02 of the Administrative Code.
