Rule 4766-2-04 sets forth the criteria used to inspect physical facilities designated by medical transportation organization as service headquarters and service satellite bases. Criteria include the licenses that must be posted, the need for a required sanitation plan and adherence to a standard of cleanliness and state and local building and fire codes. The rule also sets forth what may be inspected and when inspections may occur and references the location of the ambulance inspection form, which identifies the single use supplies and equipment that must be maintained at each physical facility. Amendments include revisions to paragraph (C) that delete eight regulatory restrictions and revise a form name. "A" is revised to "an" in paragraphs (B) and (C). The comment referencing rule 4766-2-18 is deleted.
