designated by medical transportation organization as service headquarters and service satellite bases. Criteria include the licenses that must be posted, the need for a required sanitation plan and adherence to a standard of cleanliness. The rule also sets forth what may be inspected and when inspections may occur and references the location of the "Ambulance Inspection" form, which identifies the single use supplies and equipment which must be maintained at each physical facility.

This rule clarifies the fact that a designee of the board may conduct inspections of the physical facilities and refers readers to O.A.C. Chapter 4766-2 for information about the written sanitation plan, which the rule states is required at each location, as is a copy of the Ohio state board of pharmacy license. A paragraph about when operations may commence at headquarters and satellite locations has been amended to include a reference to the O.A.C. and the addition of the requirement for "satisfactory inspections of all physical locations." A proposed amendment refers readers to the "Ambulance Inspection" form rather than to O.A.C. rule 4765-2-10 for the single use supplies and equipment which must be maintained at each physical facility. Two physical facility inspection requirements are added in the proposed amendments: compliance with state and local building codes and compliance with state and local fire codes.
