Rule 4766-2-11 sets forth the qualifications for permitted ambulances and non-transport vehicles to be considered public safety vehicles and use lights and warning devices. An amendment is made to add paragraph (C), which prevents permitted ambulance being operated at the BLS non-emergency only level from responding to emergency calls or using emergency lights and audible warning devices.
