This rule sets forth the staffing requirements, including the number of staff and the

required certification levels, for medical transportation organizations (MTOs) licensed as a basic life support, intermediate life support, or advanced life support service. Paragraph (B) of the rule sets forth the requirements for non-certified personnel who drive an ambulance or non-transport vehicle for a licensed MTO. Amendments to this rule include replacing the terms "EMT," "emergency medical technician-basic," "emergency medical technician-intermediate," and "emergency medical technician" with the certification titles adopted by the Division of EMS in May 2016 to align with national EMS provider titles. The requirement for two staff members described in paragraphs (A)(1) and (A)(2) of this rule have been modified to "at least" two. The vehicle operator course required of staff prior to their driving or operating an ambulance or non-transport vehicle has been identified as meeting the requirements of the national highway traffic safety administration's "1995 Emergency Vehicle Operators Course (Ambulance): National Standard Curriculum."
