This rule sets forth the grounds for suspension, revocation, or denial of the licenses and permits issued to medical transportation organizations (MTOs) by the Ohio Medical Transportation Board, and since its merger with the Ohio State Board of Emergency Medical, Fire, and Transportation Service in 2014, by the State Board of EMFTS. The rule sets forth its compliance with Chapter 119. Of the R.C. and lists the circumstances that may lead to sanctions for failure to comply with Chapter 4766. Of the R.C. and the rules promulgated thereunder.
