TO BE RESCINDED

4766-3-01 **Application for licensure.**

Except as provided in section 4766.09 of the Revised Code, no person shall furnish, operate, maintain, advertise, or engage in or profess to engage in the business or service of transporting persons who are seriously ill, injured, or otherwise incapacitated in this state unless licensed under this chapter according to the following procedures:

- (A) Each applicant for licensed service certification shall file with the board a written application on the form prescribed by the board and shall submit the application to the board accompanied by the appropriate fee. Applications for license renewals must be submitted at least thirty days prior to the expiration date of the current license.
- (B) Each application for licensure shall include:
 - (1) The name and business address of the operator of the organization for which licensure is sought;
 - (2) The name and primary location under which the applicant will operate the organization;
 - (3) A list of the names and addresses of all officers and directors of the organization;
 - (4) A description of each vehicle to be used, including:
 - (a) Make and model;
 - (b) Year of manufacture
 - (i) Replacement of the chassis or patient compartment of a licensed ambulance will require that all changes or additions comply with all specifications set forth in the general service administration star of life ambulance, KKK-A-1822 standard in effect at the date of manufacture of the vehicle chassis;
 - (c) Mileage;
 - (d) Vehicle identification number;
 - (e) Color scheme, insignia, name, monogram, or other distinguishing

characteristics to be used to designate the applicant's vehicle.

- (5) Street address, city, and county of all satellite locations;
- (6) The name of the primary contact person, emergency telephone number and business or administrative office telephone number where contact can be made during normal business hours;
- (7) a Proof of sufficient liability insurance, in the amount of not less than five hundred thousand dollars per occurrence and not less than five hundred thousand dollars in the aggregate, for any cause for which the licensee would be liable;
- (8) A certificate of liability insurance that includes a thirty day notice of cancellation to the board;
- (9) A current list of medical personnel including certification or licensure number, level of certification, and if applicable, proof of completion of the training specified in paragraph (B) of rule 4766-6-04 of the Administrative Code.
- (C) Each ambulance, with its equipment as required by these rules, shall be made available for inspection by the board in accordance with section 4766.07 of the Revised Code before the board deems the application to be complete;
- (D) If an application for licensure is incomplete, the board may notify the applicant that the application will not be processed until it is complete.
- (E) Station wagons, mini-vans or any other vehicles not titled as ambulances are not eligible for permits as ambulances, but may be issued permits as "non-transport vehicles" pursuant to section 4766.07 of the Revised Code, provided they fall within the definition of such vehicles in division (K) of section 4766.01 of the Revised Code.
- (F) Minimum requirements for a non-transport vehicle are:
 - (1) A working two-way communication system;
 - (2) The display of the company logo, insignia, or name on both sides and rear of vehicle;
 - (3) Appropriate audible and visual warning devices;

(4) A fire extinguisher (ABC - minimum five lbs.).
