This rule is being filed according to a RC 106.03 periodic rule review.

Rule 4766-3-03 sets forth the fees that ambulette services are required to submit to the EMFTS Board with initial and renewal applications when applying for a license to operate providing ambulette service; for a vehicle permit and inspection or reinspection of an ambulette, which is a requirement to obtain a vehicle permit; to acquire a temporary permit; or to acquire a reprinted vehicle decal to replace a lost,

damaged, or incorrectly applied decal or a decal created based on incorrect vehicle information provided by the service. Amendments include deleting paragraph (G) and revising "shall" to "may" in the last paragraph, which becomes the new paragraph (G).

Rule 4766-3-03 sets forth the initial and renewal license fees, vehicle permit fees, inspection and reinspection fees, and a fee that may be charged when a vehicle decal is reprinted. Initial and renewal license fees are \$100 annually. Vehicle inspection and reinspection fees are \$50 per inspection. Permit fees are \$50 per vehicle an an annual basis. When a fee is charged to re-print a decal, it is \$5.

Rule 4766-3-03 sets forth the initial and renewal license fees, vehicle permit fees, inspection and reinspection fees, and a fee that may be charged when a vehicle decal is reprinted. The license and permit fees are set pursuant to section 4766.05 of the R.C. Vehicle inspection fees of \$50 per inspection were set by the Ohio Medical Transportation Board prior to its merger with the EMFTS Board in June 2013, pursuant to section 4766.03 of the R.C., and based on actual costs at that time. The proposed rule revisions do not change the license and permit fees or the vehicle inspection fee.

Initial and renewal license fees are \$100 annually. Vehicle inspection and reinspection fees are \$50 per inspection. Permit fees are \$50 per vehicle an an annual basis. When a fee is charged to re-print a decal, it is \$5.

D. Is it likely that the rule will directly reduce the revenue or increase the expenses of the lines of business of which it will apply or applies? Yes

Rule 4766-3-03 may reduce revenues or increase expenses, depending on the number of vehicles requiring inspection or re-inspection and the number of satellite bases requiring an initial or renewal license.
