OAC 4766-3-05 sets forth the record keeping requirements for licensed ambulette

services, including: (1) the documents which must be maintained at headquarters facilities; (2) a current certificate of liability insurance; and (3) client transportation records.

Changes to this rule include: modifying the requirement for records to be maintained by the service to "maintain or have readily available at its headquarters"; adding "valid" to the existing "current" to describe the required certificate of liability insurance; adding a requirement for the maintenance of periodic mechanical safety inspection documentation, which is related to the addition of required inspections proposed in the amendments to OAC 4766-3-09; describing the list of client records to be maintained as a "minimum" requirement and adding "service vehicle number" to that list. A paragraph has been added to clarify that a list of vehicles and related information is not required when the certificate of liability insurance indicates "any autos" or "all autos owned." The tagline is proposed to be changed from "Transportation records." to "Record keeping requirements."
