This rule requires ambulette services based outside of Ohio that are on-boarding

patients in Ohio for transport to an Ohio location to become licensed in Ohio and to obtain Ohio permits for ambulettes used to transport patients within Ohio.

C.) Does this rule require specific expenditures or the report of information as a condition of compliance? **Yes**

This rule does require specific expenditures and the report of information as a condition of compliance. To operate as an ambulette service in Ohio on-boarding patients in Ohio for transport to Ohio locations, out of state ambulette services must become licensed in Ohio and to complete and submit the required forms to obtain the license and Ohio permits for ambulettes used to transport patients within Ohio. The cost of compliance to these ambulette services will be the annual ambulette service licensing fee of \$100 and the annual per vehicle permit fee of \$50 for each ambulette used to transport patients within Ohio.
