The rule sets forth the requirement for ambulettes to demonstrate proof of

compliance with the specifications set forth in Chapter 4766.07, which require the inspection of the equipment and interior of medical transportation vehicles to determine the operational condition and safety of the equipment and interior of the vehicle. This rule identifies the roadworthiness and vehicle configuration and cleanliness requirements to be qualified for an ambulette permit and provides standards for displaying a service's name on its vehicles. The rule requires that permits be unobstructed at all times and states that permits are not transferable. As set forth in the rule, inspections may be unannounced at any time and at any location of a licensed ambulette service.
