This rule states that inspections for roadworthiness, equipment, cleanliness, and vehicle signage requirements may be unannounced; that deficiencies identified by the EMFTS board must be corrected; that permits are not transferrable; and that vehicles that do not comply with requirements may be placed out-of-service until passing a reinspection.
