Rule 4766-4-12 sets forth the process for obtaining a temporary vehicle permit, valid for a period not to exceed sixty days, for an MolCU or non-transport vehicle that may be used to replace a permitted ambulance or non-transport vehicle removed from service and defines the emergency circumstances under which a licensed medical transportation organization may utilize "whatever means necessary to transport and

treat patients." Amendments include adding a reference to the MTLS online system and deleting a reference to an application form replaced by the MTLS online system and deleting the comment related to the incorporated by reference rule. Paragraphs (C), (D), and (E) are deleted. The list of information submitted to obtain a temporary permit is revised, and a new paragraph (C) is added requiring temporarily permitted MolCU or non-transport vehicle to meet specified roadworthiness and insurance requirements.
